## Pre-authorized Giving (PAG)

### What is the Pre-authorized Giving (PAG) Plan?

The work of our parishes is made possible through the generosity of our parishioners, who embrace their responsibility to their spiritual home.

- We give because by our gift we define our lives as giving people
- We give because we are grateful to God, who has given much to us
- We give because we appreciate our parish
- We give because we want to participate in the ongoing work of the Church
- We give because we desire that the Gospel influence our world
- We give because we share the burdens and the blessings of our Christian community
- We give because Jesus calls us to use our money responsibly and charitably.

Pre-authorized Giving allows parishioners to make their regular Sunday offering using the "direct debit" system. When you participate in PAG, your regular Sunday offering is only withdrawn from your account once a month and deposited into the parish account. That means your "once a month" amount will be about four times as much as your "once a week" amount.

We are committed to keeping your personal information confidential and secure. The PAG system uses sophisticated security measures, including encryption. The Diocesan Office of Financial Administration administers the program for participating parishes, and the parish will continue to issue your tax receipts.

### How do I enroll in Pre-Authorized (PAG) giving?

1. Decide on the amount of your monthly offertory contribution to be withdrawn from your bank account and tick the corresponding box in the next panel.
2. Fill out the form on the reverse of the next panel. Include a blank cheque marked "VOID".
3. Place both in a sealed envelope and put it in the collection basket or drop off or mail it to your Parish Office.

### Will I still use envelopes?

If you prefer to not have automatic debit for the special collections you will need the envelopes.

### Benefits for you and the parish

Pre-Authorized giving is convenient. Your offering is deducted automatically. PAG allows you to support your parish when you are away—a benefit to the church, since expenses continue all year long. Most importantly, you are in control. You can increase or decrease you amount or withdraw from the PAG plan simply by dropping a signed note in the collection basket.

I understand that the *Roman Catholic Bishop of Nelson* will **administer** this Pre-authorized Debit Agreement (PAD).

### Details & Authorization

I, the Payor, authorize the parish listed on the reverse and the financial institution designated on the attached void cheque to begin deductions on or around the 15th of each month in the amount of:

- \$433.34 (equal to \$100/week or \$5,200/year)
- \$260.00 (equal to \$60/week or \$3,120/year)
- \$173.34 (equal to \$40/week or \$2,080/year)
- \$130.00 (equal to \$30/week or \$1,560/year)
- \$65.00 (equal to \$15/week or \$780/year)
- Other monthly Amount \$\_\_\_\_\_
- Apply the same amount or \$\_\_\_\_\_ to each special collection

### How to decide what your monthly donation amount will be:

If you usually contribute \$40 a week, to maintain the same level of giving, you would need to donate \$173.34 a month. Why that odd amount? Because there are not exactly four weeks in each month, so it is necessary to multiply your weekly amount by 4.33 not 4.

I may revoke my authorization at any time subject to providing at least **30 days written notice**.
